Welcome: The Vice Chair welcomed everyone to the meeting.

The minutes of last meeting were circulated and accepted on the proposal of Robbie RM and seconded by Peter PFDH.

Police Update:

BCC received an email update:

1 Domestic aggravated assault, 2 males charged.

Overall, the crime rate has increased, however this is due to 20 caravans being broken into in Dornoch, CID have an ongoing investigation.

Peter PFDH advised the police have apologised regarding the lack of updates, they now have a system in place to ensure there is more dialogue & interaction with BCC, however this will not be in person regular email communication is the preferred option. The police will attempt to attend four meetings a year. Peter PFDH & Gina GS attended a meeting last week, Gina will get an email address that the public can use, it was stressed that for urgent issues 101 should still be the main point of contact, for ongoing non urgent issues the public can contact BCC or email the police when the email address becomes available.

From the Floor: Place Plan, why isn't it ever discussed in matters arising? Extreme disappointment this still hasn't been completed, following discussions David DA (Chair) advised Russell has been liaising with a consultant who has carried out much of the work, BCC are awaiting the outcome of a funding request from Kilbraur Wind Farm Community Benefit Trust for £2500. It was pointed out that it would only be a paper exercise as no community consultation has been carried out, which is the basic premise of a place plan. There was confusion as to what extension time BCC had been given to complete the work, after checking the Highland Council Website Peter PFDH gave the following information Local Place Plan submissions that pass the validation check by Friday 27 June 2025 will be registered, if that deadline is missed then the next validation check is Friday 12 December 2025, Richard RG advised the place plans must be submitted well before these dates in order for the validation checks to be processed.

Ellen Lindsay once again offered the services of the Brora Development Trust to work with BCC to complete the Place Plan if the BCC are aiming to work to the December 2025 deadline. BCC to Liase with BDT to decide how to move forward to get the Place Plan completed. Ellen Lindsay also confirmed no charge would be made for their work.

All present agreed the Place Plan should include the aspirations of the local community.

David DA (Chair) will discuss with the BCC & ensure the Place Plan is an ongoing & updated item in future BCC meetings.

From the Floor: It was agreed the light up "Slow Down" signs are very effective as a speed deterrent.

Peter PFDH (on behalf of Ruwan RUP) There is a concern about campfires, BBQs etc especially on the beach near the Harbour given that Wildfire Alerts have been issued across the Highlands, following discussion it was agreed BCC would put up posters in the local area stating "No Fires", the exception to this is the Muirburn, a traditional practice in the Scottish Highlands, involves the controlled burning of heather and other moorland vegetation to promote new growth, improve grazing, and manage habitats, the standard muirburn season runs from 1 October to 15 April. Richard RG Rangers are to educate (mainly tourists) they have no powers of enforcement, if necessary, they will call the police, the public should call the Fire Brigade if they are concerned about campfires etc. They should be aware of their own safety if approaching anyone about fires.
